Medical Insurance Notes

Please note that failure to disclose a known medical condition may invalidate medical insurance. During their time at the college, students will be required to attend out-of-College activities. The College will take all reasonable and necessary precautions to ensure the welfare and safety of all participants. At all times during the visits students are subject to normal College regulations, and must conduct themselves so as to bring credit to themselves and the College. All participants will be covered by insurance taken out by the College for the duration of the activity. However, personal injury cover is NOT provided by the College. The participant, or his/her parent or guardian if he/she is under 18, must sign below to accept this.

It should also be noted that personal effects are NOT covered by College insurance.

Off Site Visits

A key feature of our learning structure is the involvement of our students in industry visits. It is anticipated that over the course of the academic year, students will undertake activities off site from Myerscough College. The signature provided at the base of the page will ask as permission. There is an expectation that communication will be made with parents prior to any excursion or activity outside the school being undertaken. This communication may be in the form of a letter or email. The student's home school will also be informed of the visit.

Tetanus Vaccination

The nature of Myerscough's courses mean that the college requires all students to have a tetanus injection. The signature provided at the base of the page will act as confirmation that either your child has been or will have been vaccinated against tetanus by the start of the course. If your child is exempt for medical, religious or other reasons then please provide information below.
